The IMT-GT is a subregional initiative formed in 1993 by the Governments of Indonesia, Malaysia, and Thailand that aims to accelerate “economic transformation” in the less developed areas in these countries towards a “seamless, progressive, prosperous, and peaceful subregion with improved quality of life”. Towards realizing this vision, the IMT-GT identified five strategic thrusts to: (i) facilitate and promote intra- and inter-IMT-GT trade and investment; (ii) promote the growth of agriculture, agro-industry, and tourism; (iii) strengthen infrastructure linkages and support to the integration of the IMT-GT subregion; (iv) develop human resource and skills competencies, enhance mobility of labor, and strengthen environment and natural resources management; and (v) strengthen institutional arrangements and mechanisms for cooperation, including public-private sector collaboration, participation of stakeholders at the local level, and the mobilization of support from development partners.

The IMT-GT subregion comprises 10 provinces of Sumatra, Indonesia, 8 states in Peninsular Malaysia, and 14 provinces in the Southern Region of Thailand. It is home to about 78 million people inhabiting a surface area of about 615.5 thousand square kilometres. The region is situated along the Melaka Straits, one of the world’s busiest shipping lanes, in the ASEAN region characterized as of diverse physical, social, economic, and cultural makeup.

The Leaders have called for the establishment of IMT-GT trade and investment database, to monitor the impact resulting from IMT-GT cooperation. A statistical information brochure entitled “IMT-GT at a Glance” was launched during the 7th IMT-GT Summit on 25 April 2013 in Brunei Darussalam. It provided a snapshot of IMT-GT’s significant 22% and 15% contributions to both the IMT and ASEAN economies, respectively.

This statistics booklet compiles national and/or subnational data on trade, investment, and tourism as well as population, labour force and other macroeconomic indicators in the IMT-GT Subregion and is part of the commemoration of IMT-GT’s 20th Anniversary celebrations. As a window to the world, it aims to provide sound basis for the analysis of trade and investment patterns in the IMT-GT region and to inform and support monitoring of the socio-economic impact of the IMT-GT cooperation.

This statistics booklet also serves to document the initial data holdings produced through two Phases of data coordination, collection, compilation, and documentation undertaken by the IMT-GT member countries through the IMT-GT Trade, Investment, and Tourism Database (ITITD) Task Force towards the establishment of a comprehensive statistical database. Phase 1 compiled data for an initial set of key economic indicators at the national level from the annual ADB Key Indicators and member countries while Phase II collected national and subnational (provincial or state) data and compiled subregional aggregates.

This publication has two main sections, namely, the IMT-GT Subregional Data and Country Data, consisting of statistical tables and charts on selected indicators. The Country Data is further subdivided into three subsections corresponding to the member countries’ data.



All basic data used in this booklet are from official sources as provided by the member countries through the IMT-GT Trade, Investment, and Tourism Database (ITITD) Task Force and/or through the ADB Key Indicators and ASEANstats. Some of the more recent data are preliminary and may be updated in the near future. Subregional aggregates for some indicators are estimates derived from the given country data. These estimates only serve to provide indicative information about the subregion and should be used with the proper caveats. The specific country data sources and notes about the data are provided in the pertinent tables.

The ITITD Task Force acknowledges the work and contributions of the respective Task Force country focal points namely BPS Statistics Indonesia, Department of Statistics Malaysia, and Thailand Statistical Office, and Department of Statistics of Indonesia, Malaysia and Thailand.

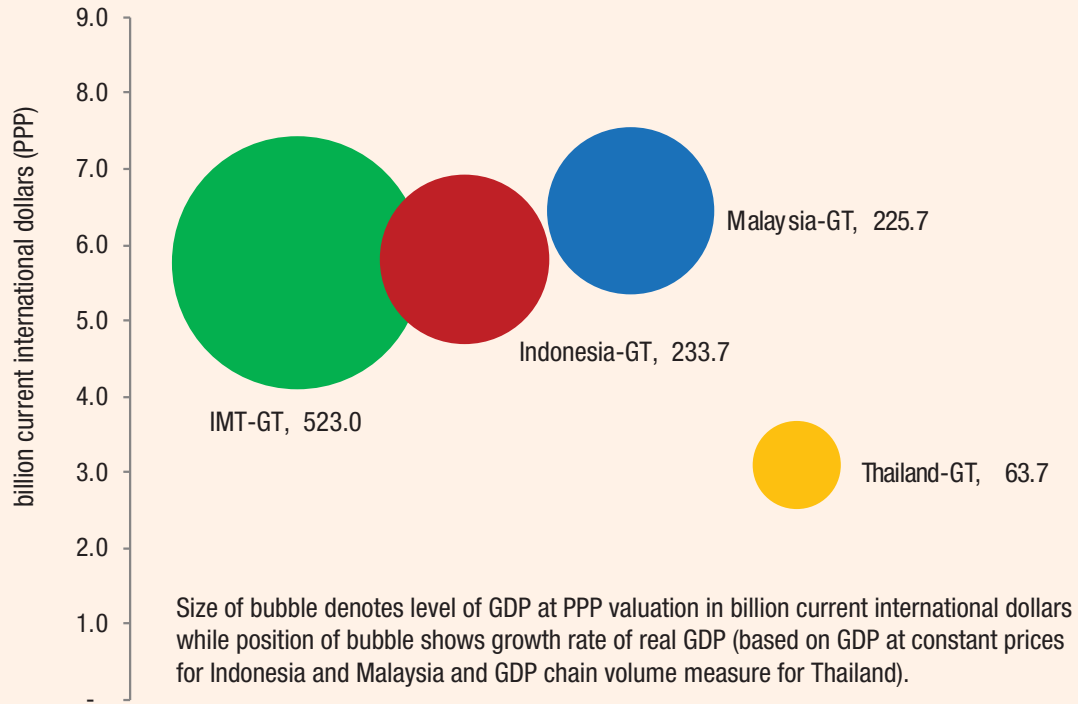

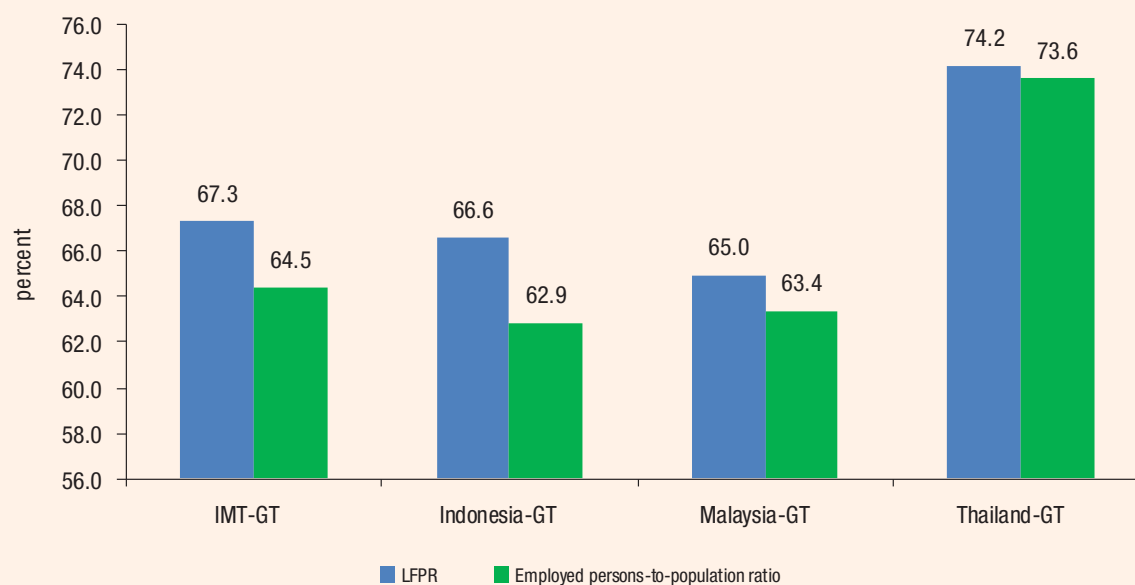

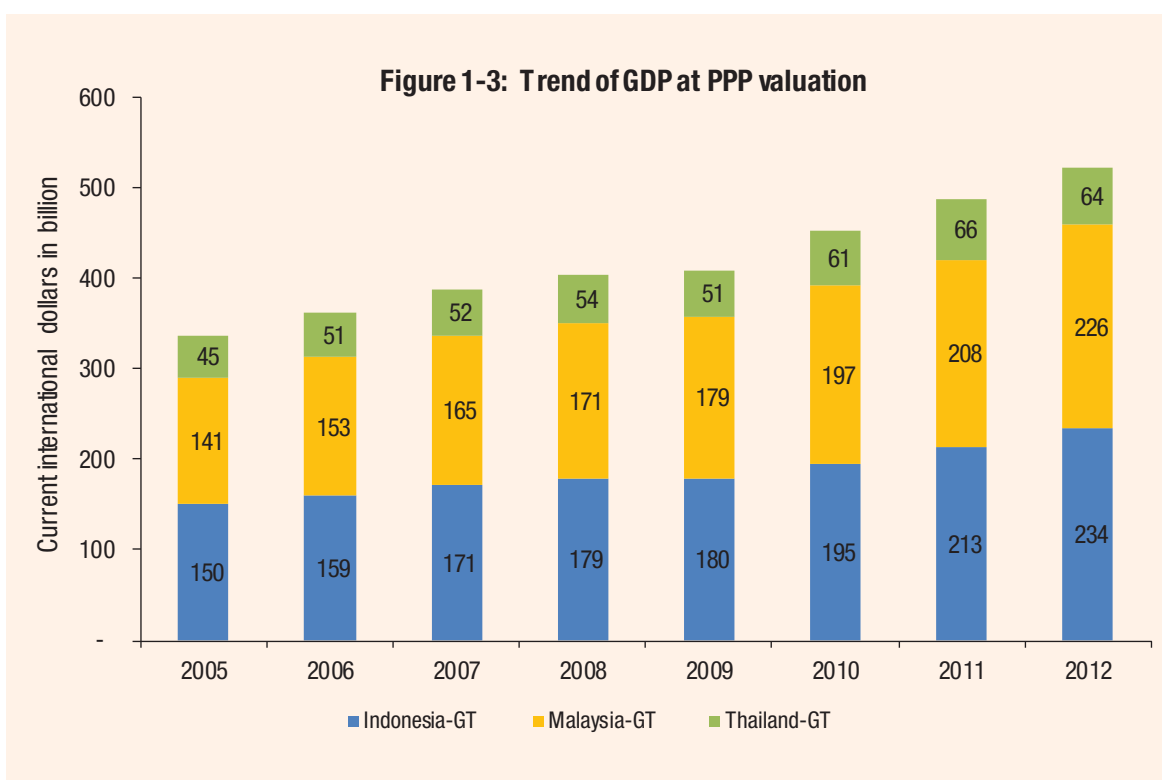

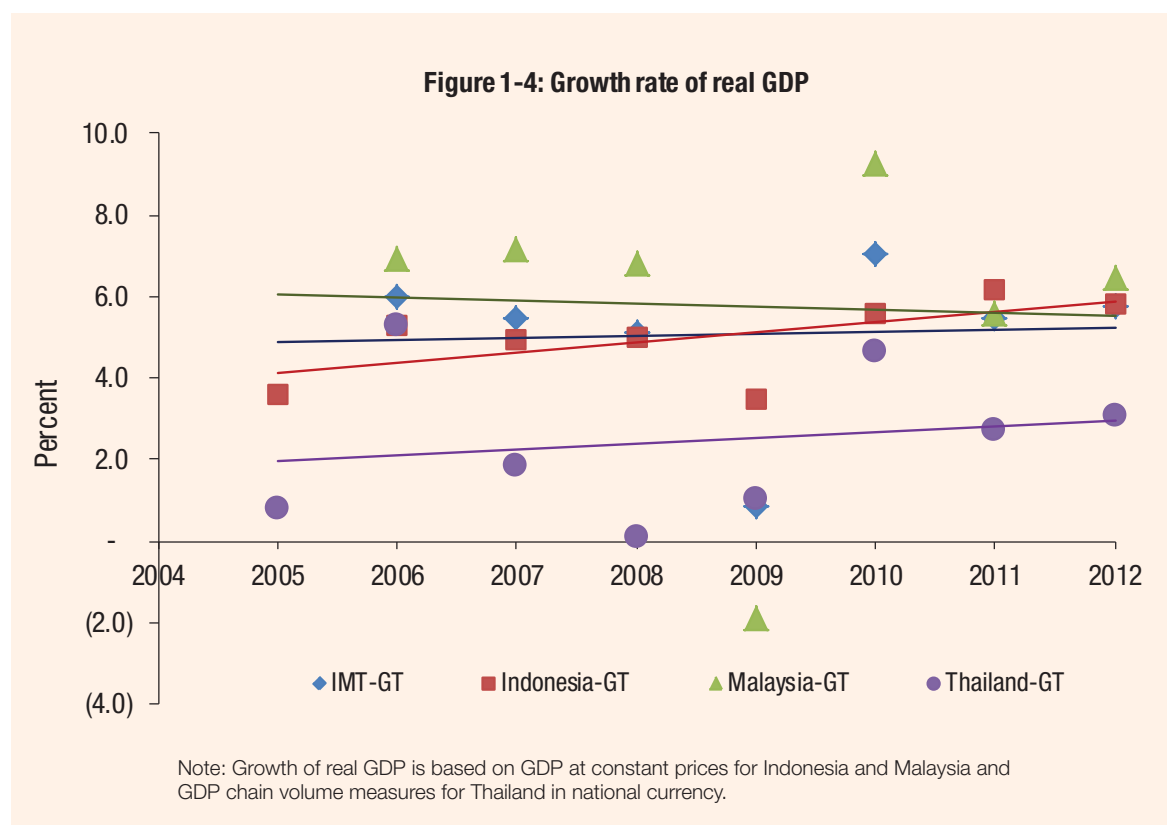

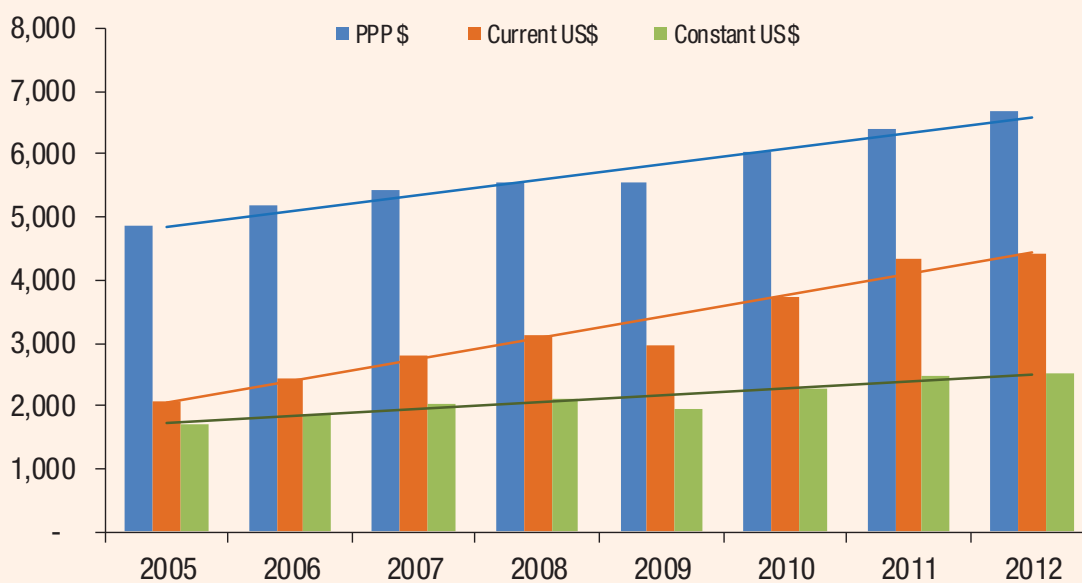

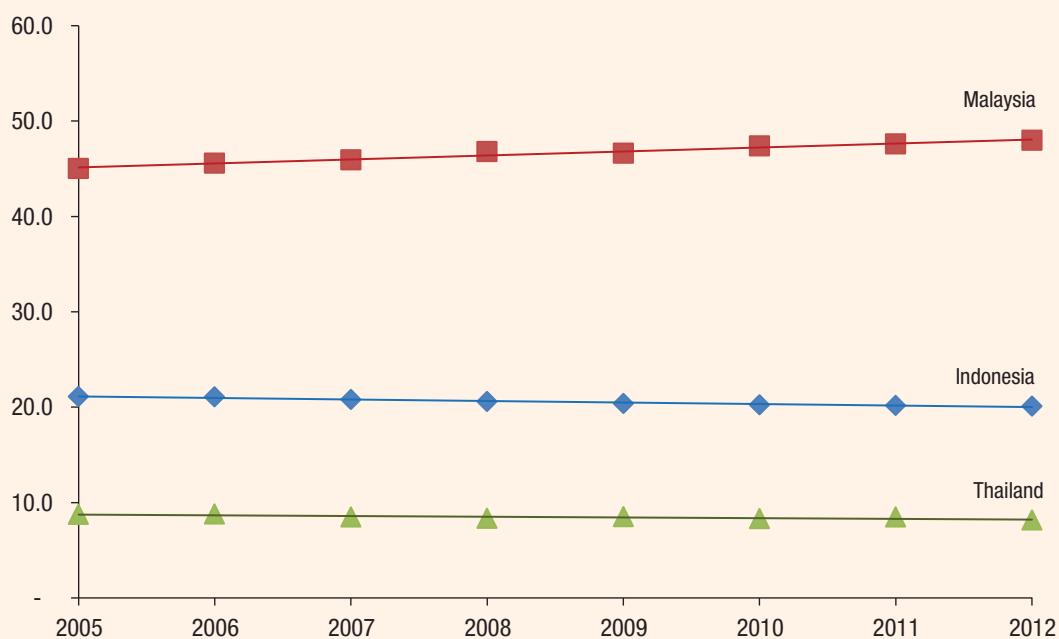

**Figure 1-6: Share of IMT-GT in the national economy**





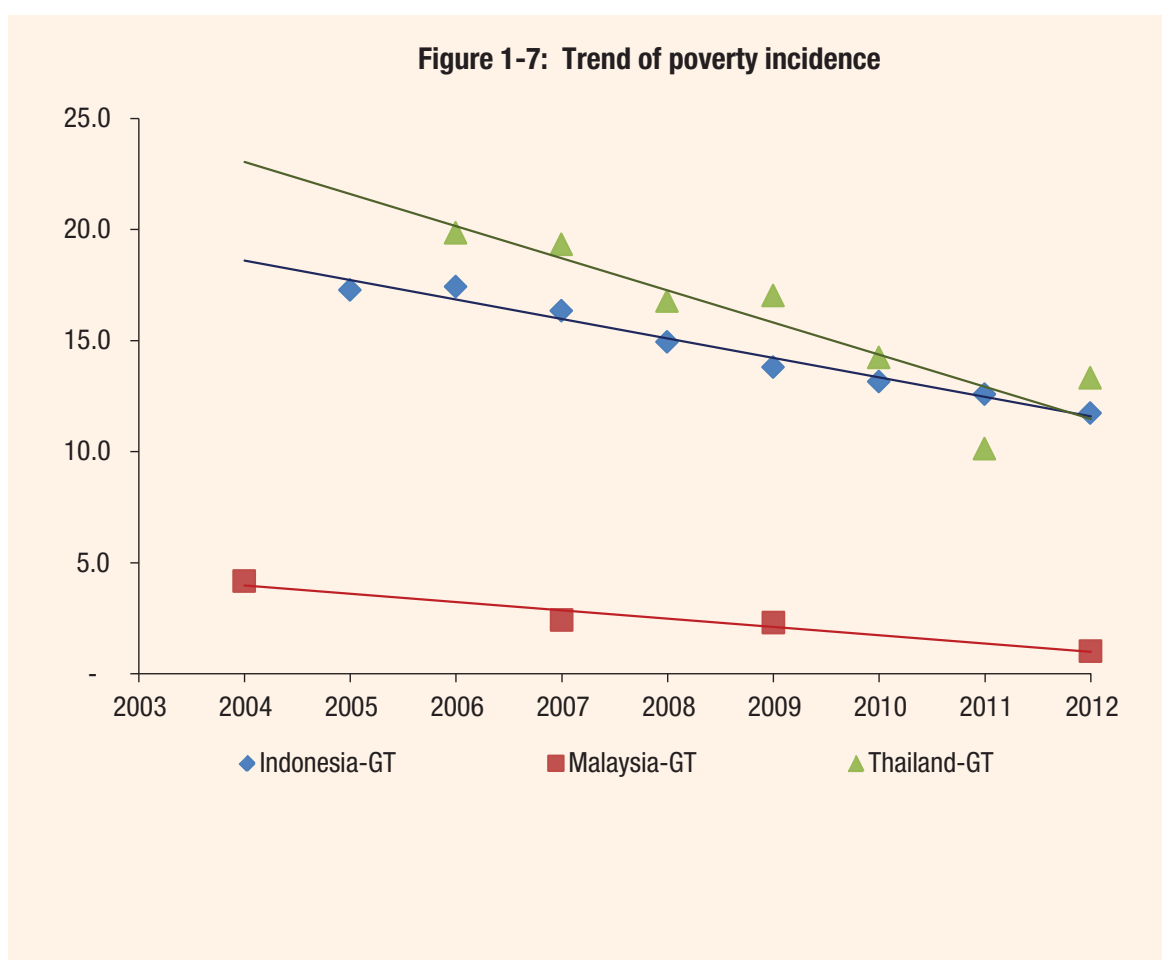

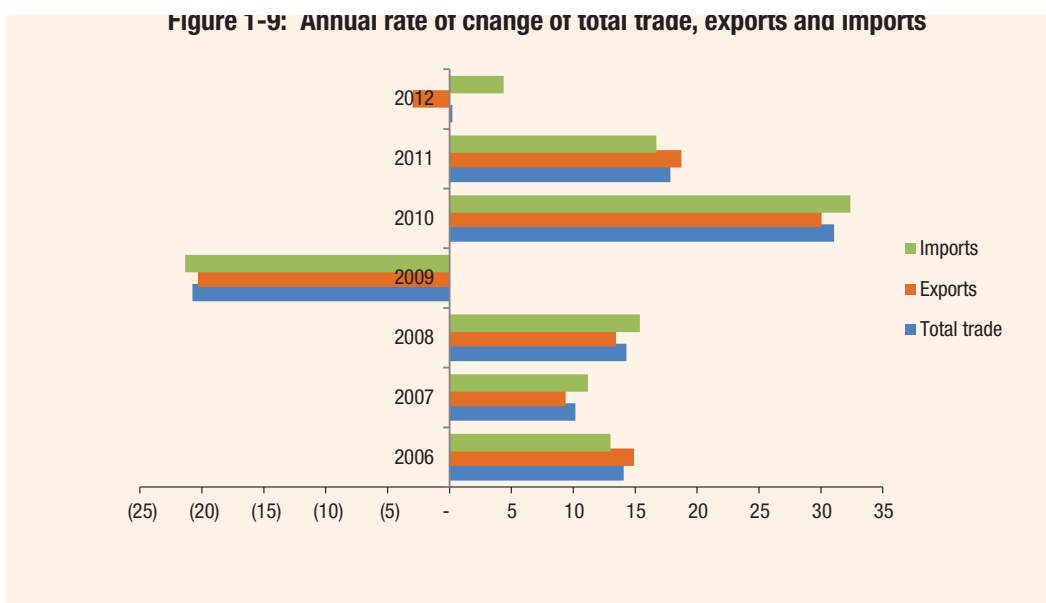

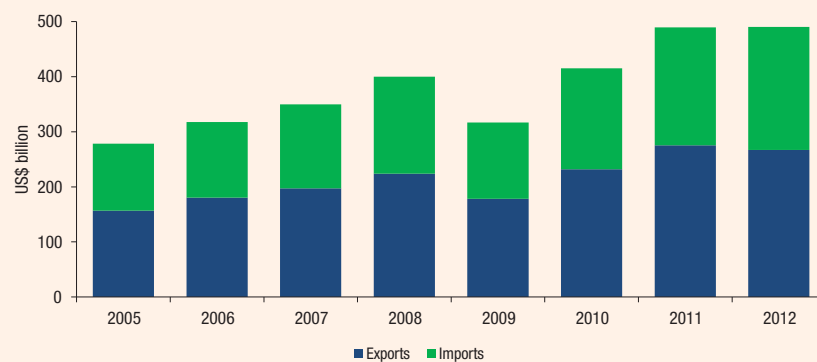

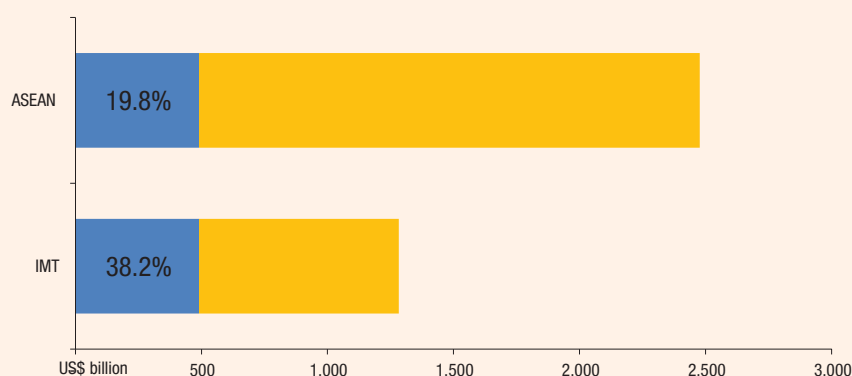

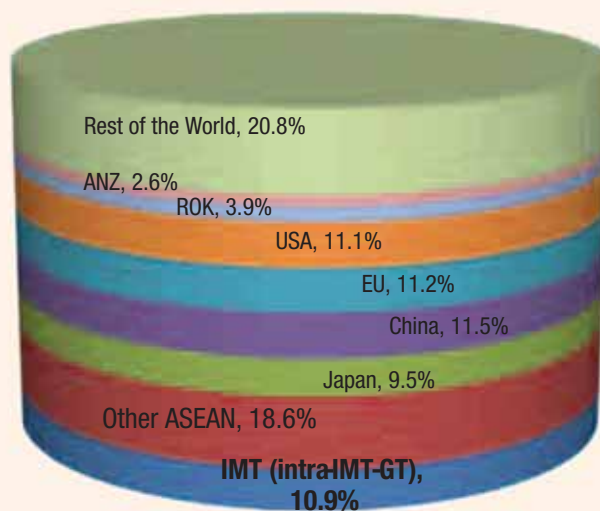

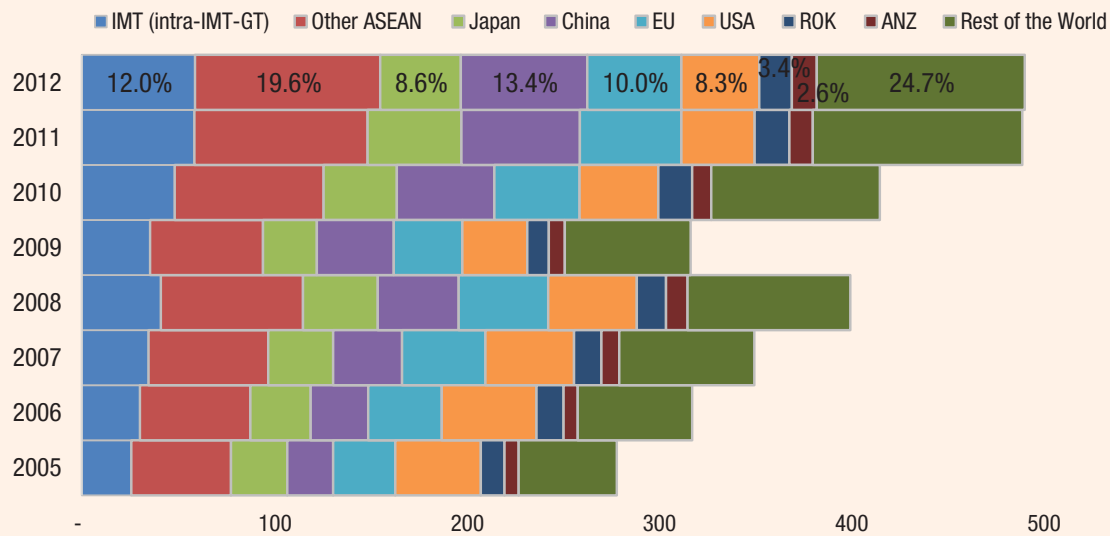

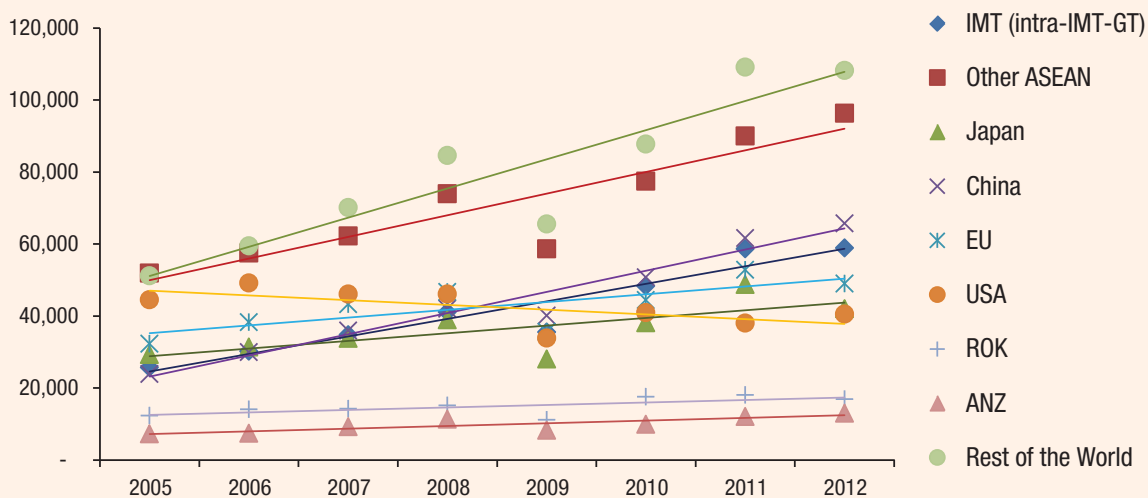

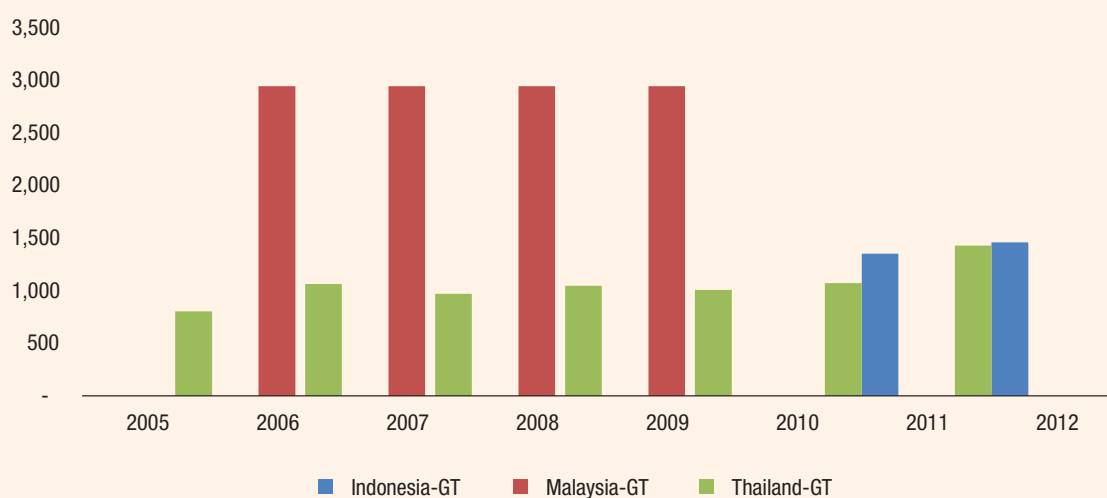

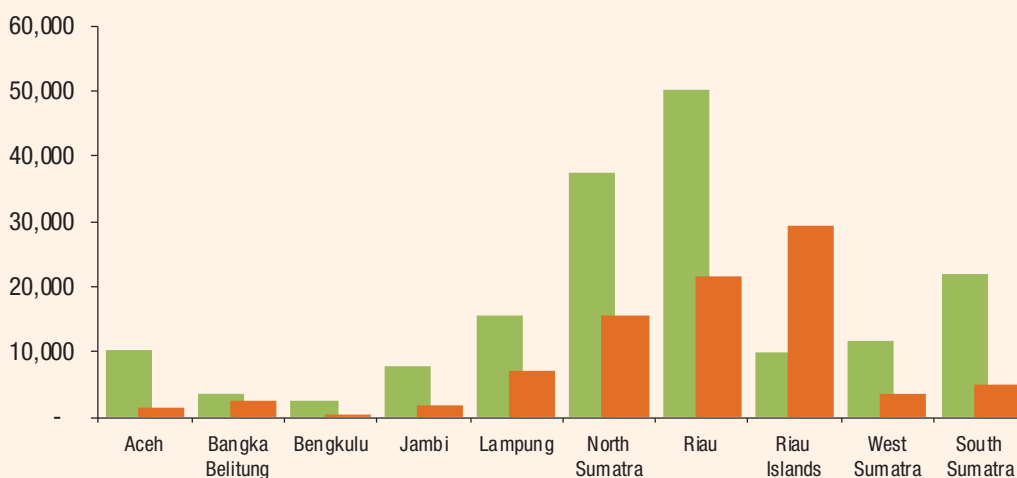

**Figure 2-1: GDP at current prices and international trade, 2012, US\$ million**



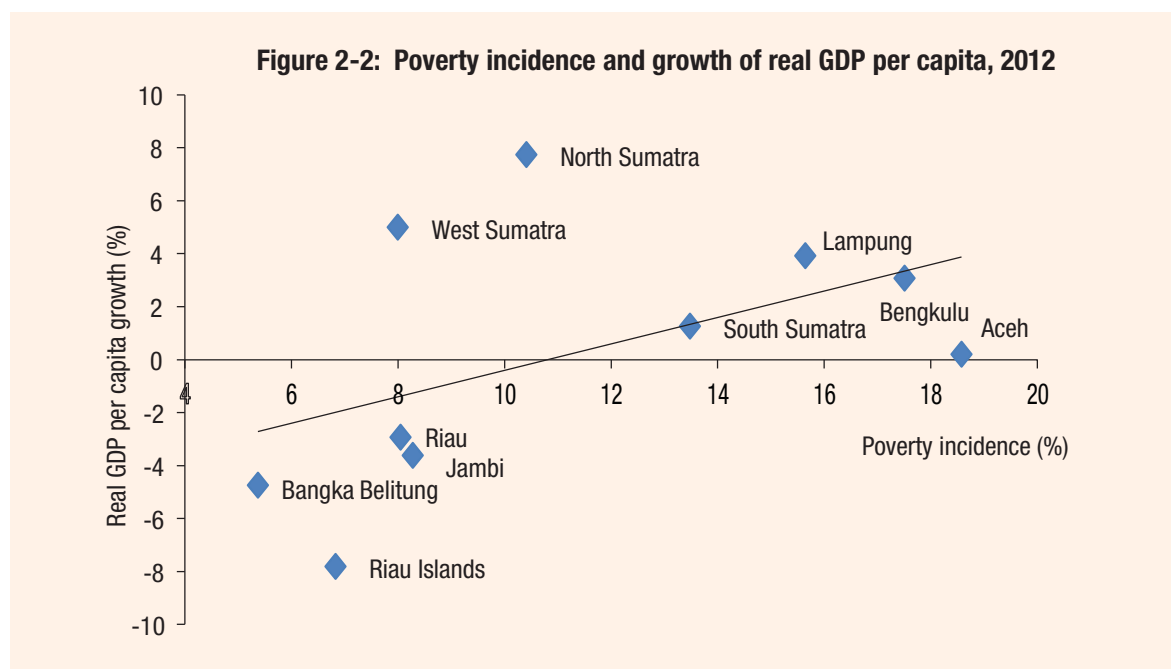

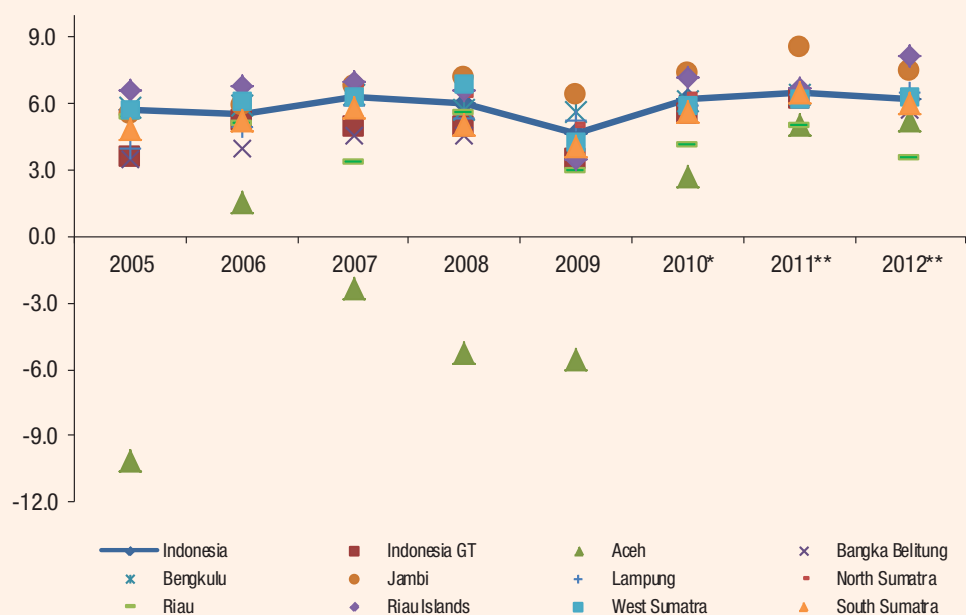

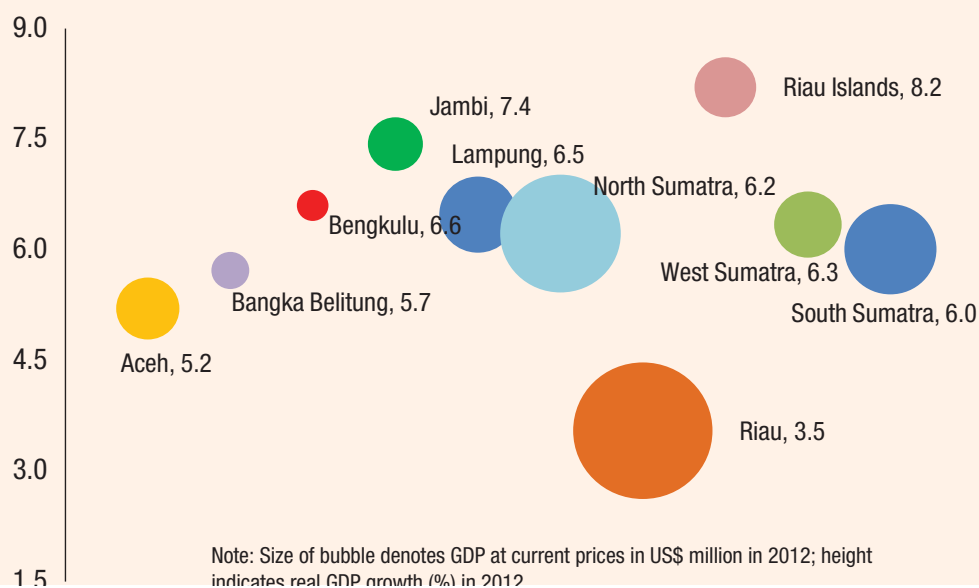

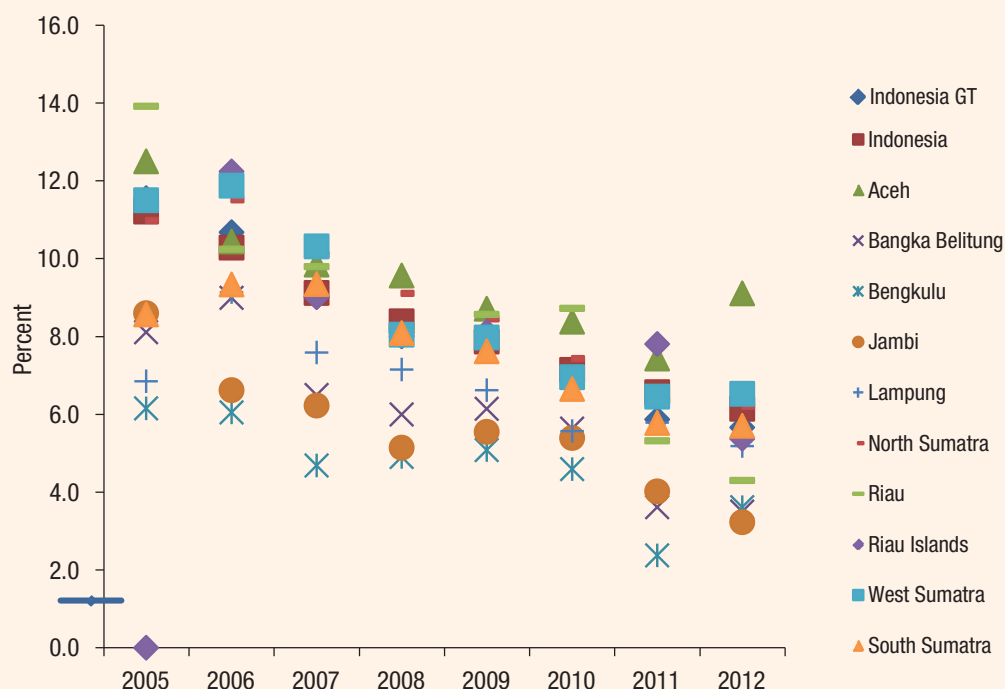

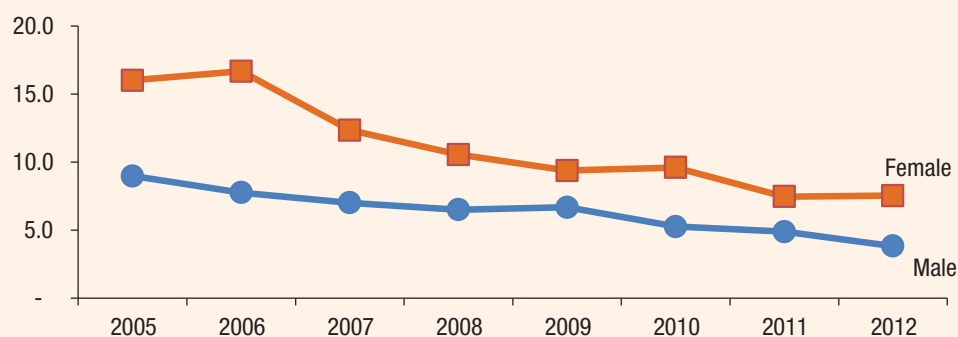

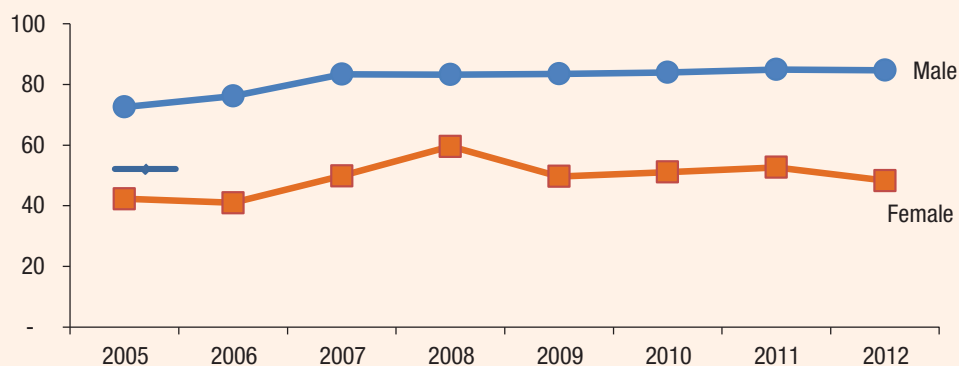

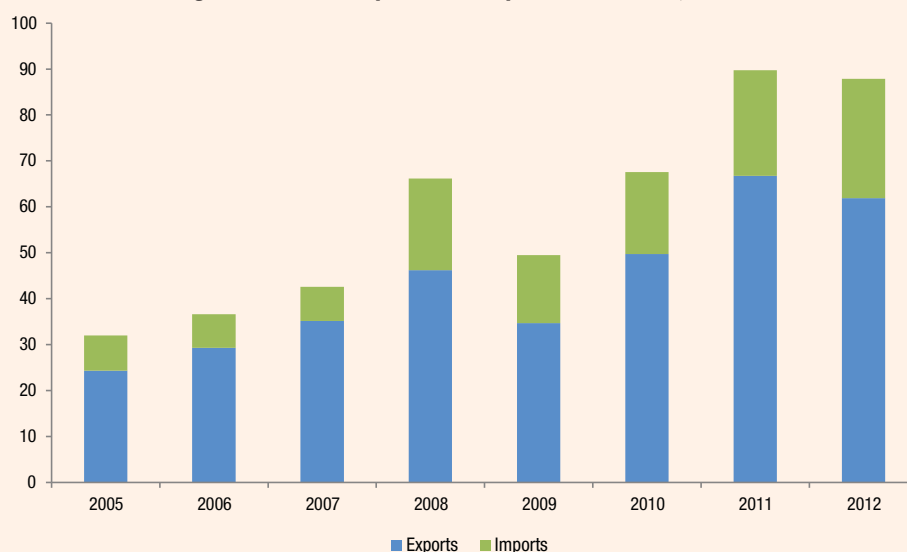

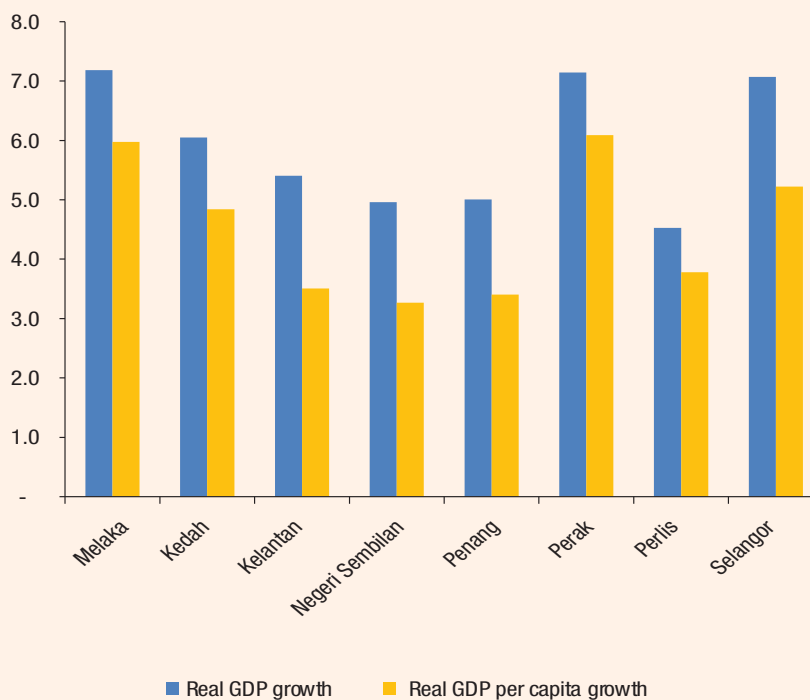

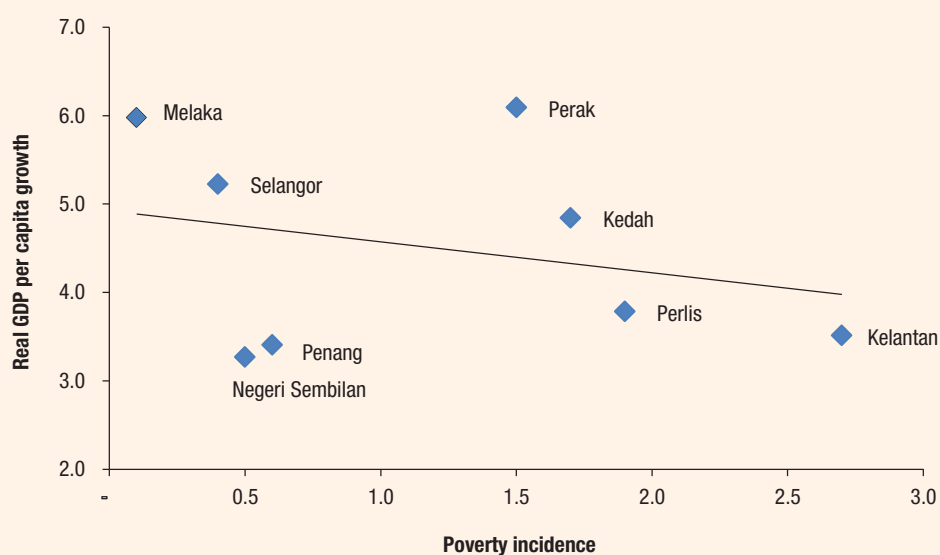

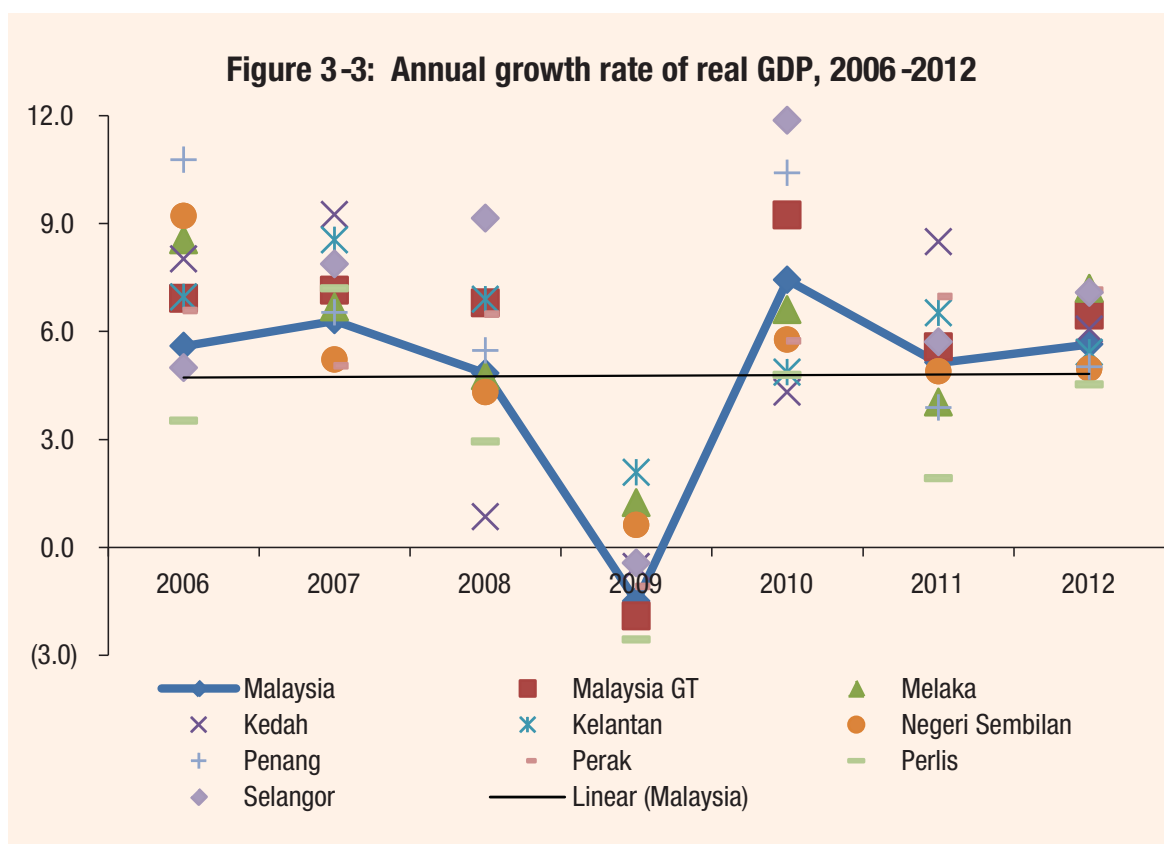

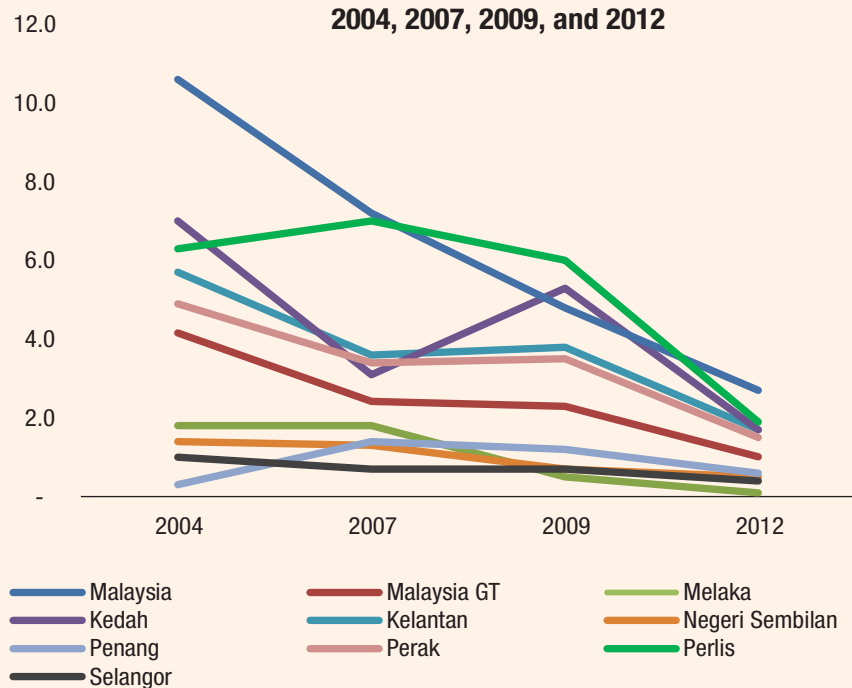

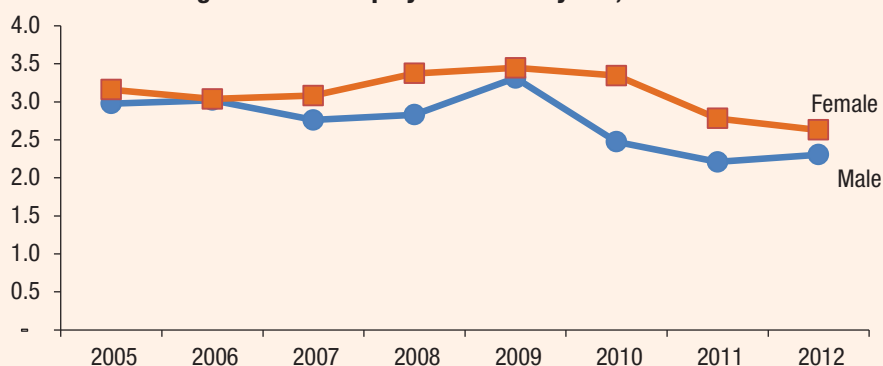

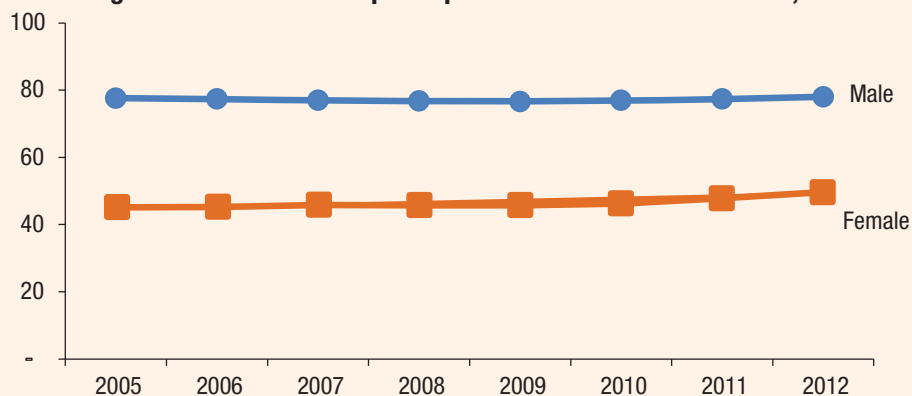

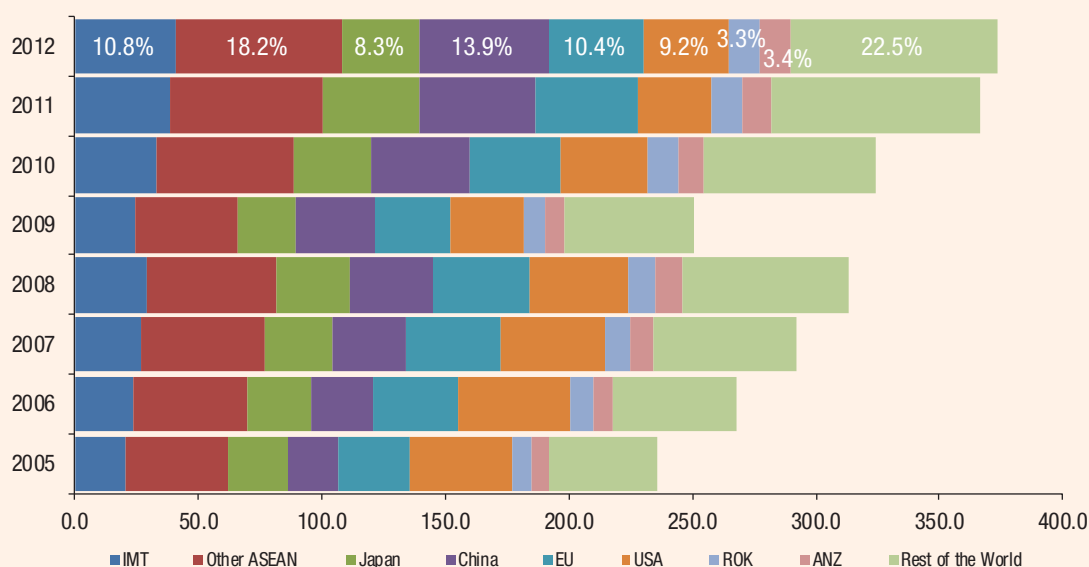

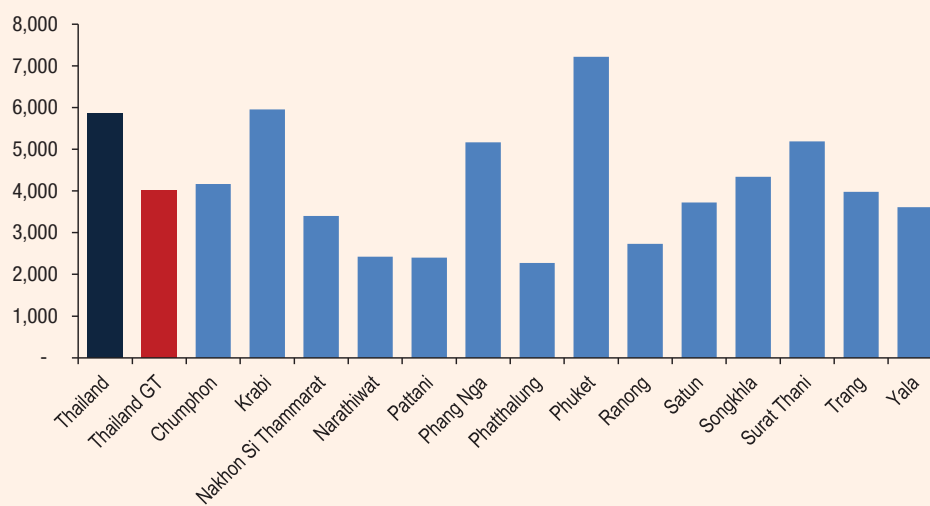

**Figure 4-1: Per capita GDP at current prices, 2012, US\$**



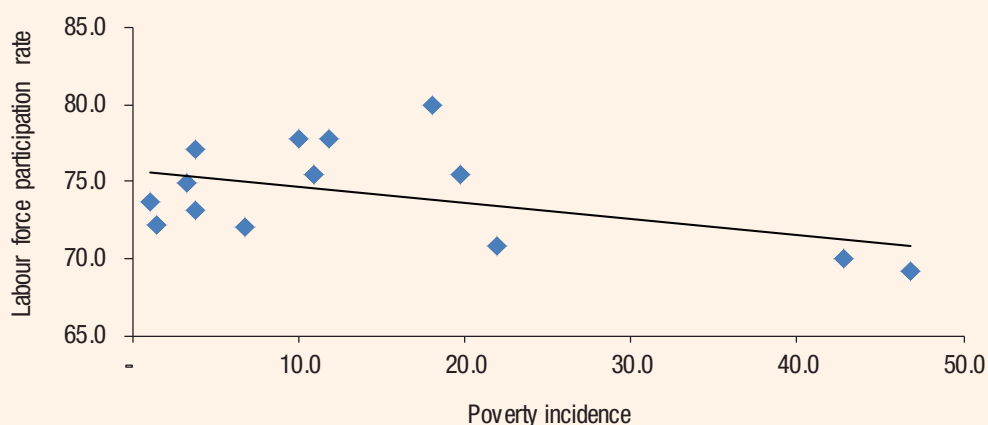

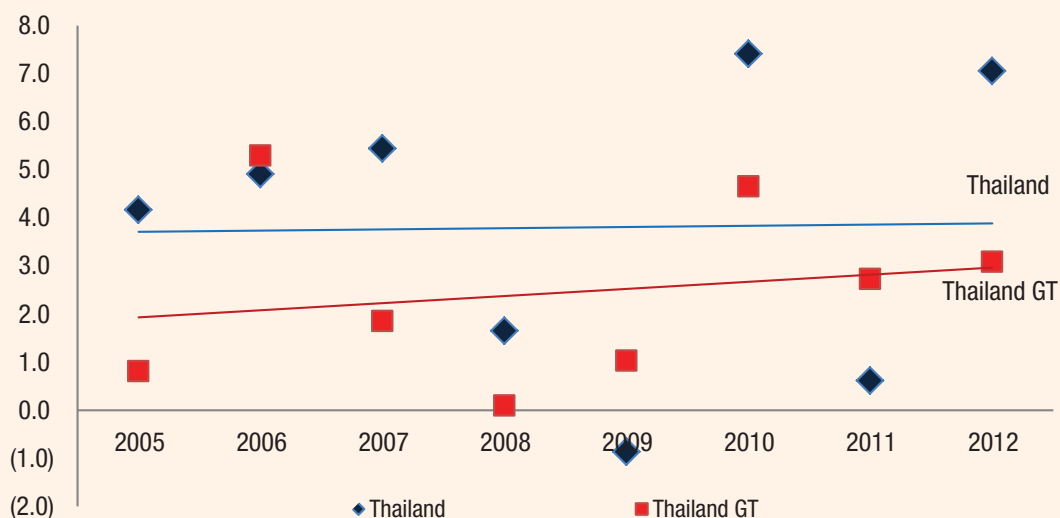

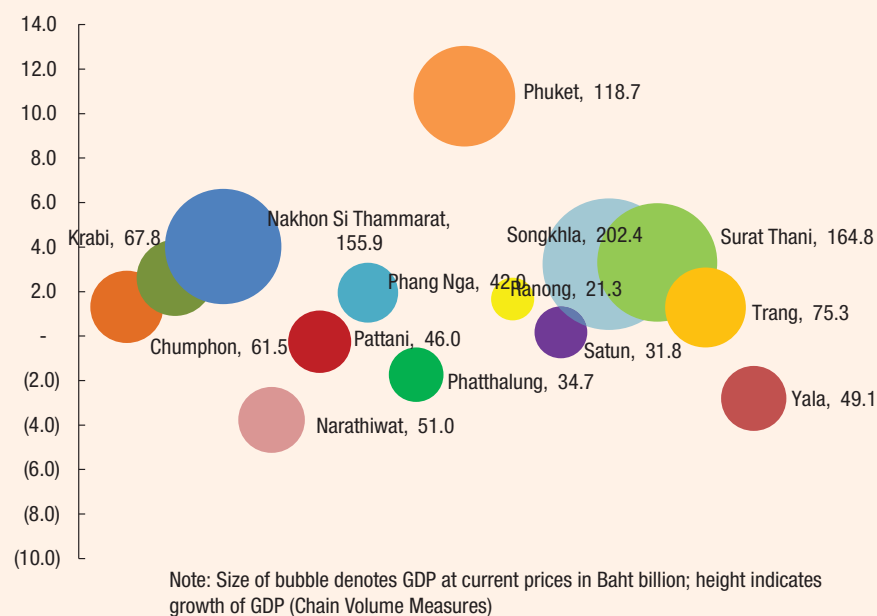

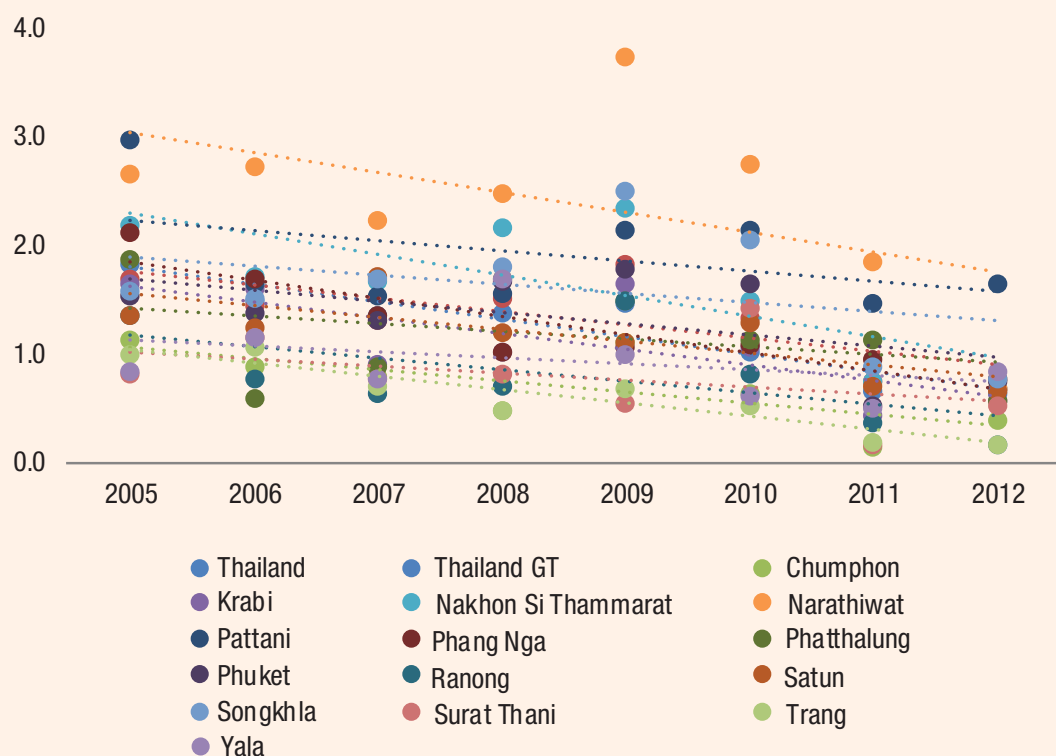

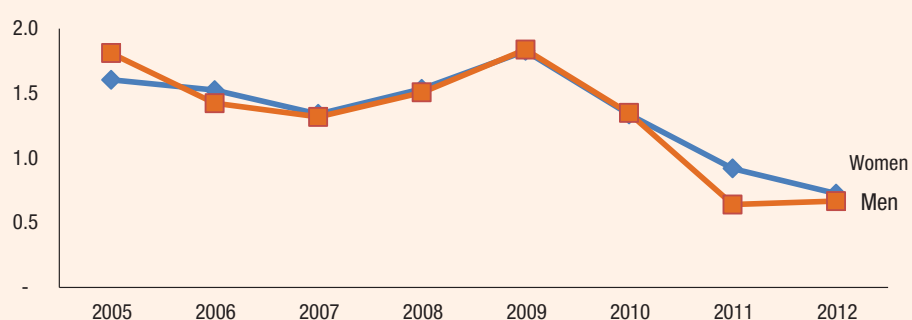

**Figure 4-7: Labour force participation rate in Thailand GT by sex, 2005–2012**

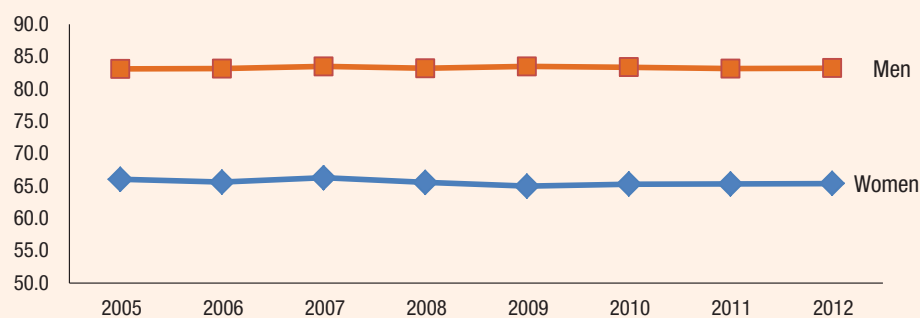

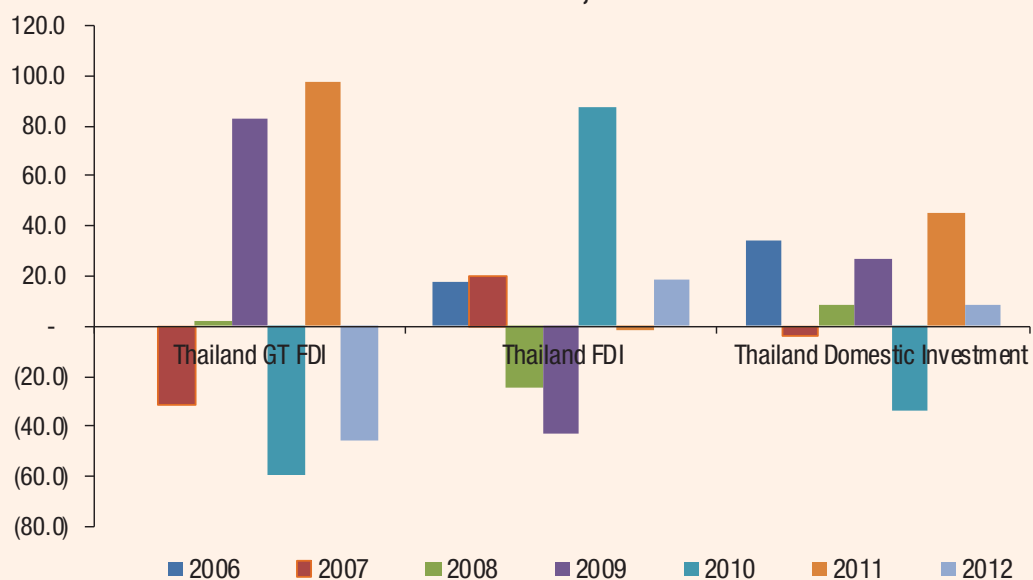

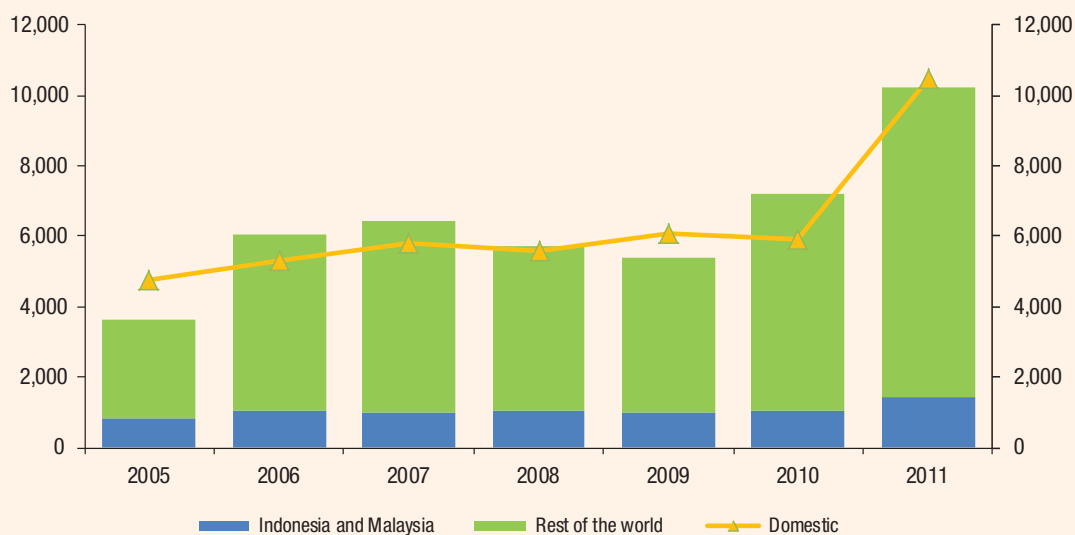
